Extract of Examination Manual Addendum – 1

MAKEUP/FAST-TRACK SUPPLEMENTARY EXAMS

MAKEUP/FAST-TRACK SUPPLEMENTARY EXAMS are offered:

- To those who have enrolled for the Regular Semester End Examinations with requisite attendance and internal marks in all the subjects/papers.
- To those who have attended the SEE and failed or remained absent for genuine reasons with the prior approval of the principal.
- In a Maximum of only 3 subjects, in which the student has either failed or remained absent.
- By considering Previously obtained internal assessment marks and attendance in the semester.

Generally, the makeup examinations are announced for the EVEN Semester examinations, which is the terminating semester for various programs (Certificate, Diploma, Degree, Honors). Makeup exams started with an aim of avoiding a year loss to a meritorious student. If the EVEN semesters examinations are followed by makeup exams, a students will not lose any year (anyway he/she will not lose as there is full carryover in NEP) Or a student will not have to wait for an year in continuing his/her education at PG level. Hence to promote academic progression among students and to encourage them to excel forward, the Makeup/Fasttrack supplementary examinations are planned to offer at the end of all Semester End Examinations (SEEs) with the following norms/conditions.

MAKEUP/FAST-TRACK SUPPLEMENTARY EXAMINATION NORMS:

- Fees: 1.5 times the regular exam fees per paper.
- Makeup/Fasttrack supplementary exams are announced after two weeks after the announcement of SEE Results, in which duration the students have the option of applying for Photocopy review and revaluation.

Justification:

1. To promote Education.
2. Supplementary Examinations are conducted by some universities and colleges after 6 months, by when the students would have forgotten the subject contents and again they might score less/fail there too. We have many such examples with us. If an additional option is given to the students as this, they will further study immediately and complete that paper.
3. Other Autonomous colleges have the policy of conducting the supplementary examinations along with all regular SEEs.
4. We do not have the policy of conducting supplementary examinations with every semester end examination. We conduct all ODD supplementary examinations with ODD SEE and EVEN supplementary examinations with EVEN SEE. So students who fail in a SEE paper will have to wait for ONE long year. The proposal of Makeup/Fastrack supplementary examination, reduces this GAP of one year and certainly promotes education.
5. As under NEP, there is no eligibility criteria for progressing onto higher semesters, the students are more likely to lose their focus on Backlog papers to be reappeared, because their focus will be generally on present papers rather than backlogs. This leads to piling up of backlog subjects at the end.
6. The Makeup/Fastrack supplementary examination is NOT allowed in all the papers of the semester, it is fixed to a MAXIMUM of THREE papers only. This, among students, avoids the mindset of taking things lightly and not being serious towards main SEE and focusing only on Makeup or Fastrack supplementary examinations.
7. The MAXIMUM of THREE papers also with certain conditions.
8. There is no any reduction in the difficulty levels in QPs for regular Examinations and Makeup or Fastrack supplementary examinations, nor there is any leniency in the evaluation too.
9. BOE scrutinized QPs will be issued for the Makeup/Fastrack supplementary examinations also.



- A student willing to take makeup or Fasttrack supplementary exams, should have attended all the Papers of that semester in the recently concluded SEE and must have secured all requisite IA marks and attendance.
- Make up or Fasttrack supplementary examinations are allowed only in a MAXIMUM of THREE papers of SEE and not in the Practical Examinations.
- If a student fails even in the makeup/ Fasttrack supplementary exams, then it will be a backlog examination to be re-appeared in the subsequent examinations, and the attendance and IA marks are further carried forward.
- To differentiate the makeup/ Fasttrack supplementary exam, a separate marks card will be issued displaying only the subjects written and passed in the makeup/ Fasttrack supplementary exams.
- A candidate who passes in the makeup/ Fasttrack supplementary examinations, is eligible only for Class and NOT for rank.

The proposal of conducting the MAKEUP/FAST-TRACK SUPPLEMENTARY Examinations was presented in the EAC (Examination Advisory Committee) and was obtained the approval of and thus implemented from the UG/PG SEE of Feb/March/April 2023 onwards, with an advice to continue the Terminology as **Fast-Track Supplementary Examinations**, as other terminologies were being used in other contexts.
