6. The Soft Copy of Course Material and certificate will be provided by **Disciples Corporate School**.
7. **Disciples Corporate School** will be fully responsible for training the students and providing the certificate.
8. The minimum batch size should be 50 students. Once the number of students are confirmed, the invoice will be raised accordingly. Non participation by few students or dropout during the course cannot be considered for altering the invoice.

# MEMORANDUM OF UNDERSTANDING

**Surana College** (Surana) hereinafter referred as First Party, (which expression shall unless repugnant to the context thereof include its successor and assignees) is a Higher Education institution with a vision to become the educational institution of preferred choice by ushering the convergence of knowledge, skills & values to produce individuals by providing holistic education, being the Vision of Surana College. Surana college believes in all round development of its students.

**Sanskrit Bharati** hereinafter referred as Second Party, (which expression shall unless repugnant to the context thereof include its successor and assignees) is a Not-for-profit Non-Governmental Organization, established in the year 1980, with the sole intention of making Sanskritam the spoken language of the masses.

Sanskrita Bharati has during the last 4 decades of existence conducted over 130000 "Speak Sanskrit in 10 days" Camps, free of cost, through more than 5000 centers all over India for over 10 million Indians cutting across all barriers of caste, creed, religion, age or any other social divide. Sanskrita Bharati has many innovative programs to reach every Sanskrit enthusiast anywhere in the country and abroad in over 18 countries. Some of the major achievements of Sanskrita Bharati include

- Offering Four level distance education -Pravesha, Parichaya, Shiksha & Kovida programs in 13 languages with over 1 lakh students,
- Setting up of over 100 centers of Bhagavad Gita Shikshana Kendram,

- Surana College has profound respect for Sanskrit language and is highly appreciative of the activities of Samskrita Bharati towards revival of the language. The College is abreast of the sacrifice & dedication of lakhs of volunteers of Samskrita Bharati towards rebuilding India as a strong nation with a view to propel it as a Vishwa Guru.

## The MoU envisages the following

- Surana College wishes to offer short-term certificate courses in Sanskrit, conduct various Seminars and Workshops, organise exhibitions, celebrate programs of importance from time to time to introduce the dynamic and vibrant word of Samskrit literature, relevant to the fields of Science & Mathematics, Medicine and Healing, Commerce and Finance, Engineering & Environment, Education and Leadership to name a few.
- Surana College wishes to empower the under-graduate students studying in various streams in its premises at South End Road, Basavanagudi, Bengaluru by providing curated courses and programs aimed at developing their character, personality and a nationalist outlook for being better and responsible citizens and nurture them as ambassadors of Bhartiya ethos and culture.
- Surana College wishes to provide a free platform for all its students without any commercial consideration for promotion, propagation and development of all activities related to Sanskrit language as an instrument for nation building.
- Surana College wishes to offer relevant programs developed by Samskrita Bharati and has approached Samskrita Bharati for support in organizing as many events, exhibitions, seminars, and workshops for its students as possible.
- Samskrita Bharati wishes to propagate, promote, and popularize Sanskrit amongst the students of Surana College.
- Samskrita Bharati wishes to identify, nurture, and develop discerning students into Transformation Leaders and empower them to lead the society towards nation building thorough volunteering efforts.



Now therefore, in consideration of the mutual promises set forth in this MoU, the parties hereto, agree as follows:

1. Arrange 'Sanskrita-Sambhashana-Shibiram' for the students of Surana College on hybrid mode.
2. Conduct regular contact classes for the students on hybrid mode for interested students of Distance Education program.
3. Provide relevant study materials for gaining flair and fluency over the language.
4. Conduct Guided Programs, Guest Lectures, Competitions, Seminars and Workshops for teachers and students of Surana College.
5. Facilitate establishment of a Sanskrit Research Cell and provide in-depth training for the students in research methodologies in Sanskrit related subjects relevant to the field of their study, through third party organisations
6. Facilitate publication of papers in journals in reputed journals.
7. Provide 2 years Residential Leadership programs for select students post completion of their graduation with assured hiring challenges.
8. Offer in-depth training in content creation and technical editing for online repositories.

For the avoidance of doubt, this agreement is signed as an expression of interest of commitment of both parties toward public good and promotion of Sanskrit Language and is not intended to create any long-term legal obligations between the two parties.

This MoU will be periodically reviewed by each party and the term of this MoU may be extended, amended, or curtailed by mutual agreement and would thence form part of this MoU.

## PREAMBLE

This agreement is made on 20 April 2022 between:

MIT Square Group of Companies (consists of MIT Square, India & London) (hereinafter called MIT Square) headquartered/registered at 20, Halcyon Villas, Banjara Layout, Horamavu, Bangalore - 560043, Karnataka, India; 160 Kemp House, City Road, London, Great Britain, UK - EC1V 2NX and Surana College (hereinafter called Institution), located at Bangalore, India.

The objective of this Memorandum of Understanding is:

1.5 The company offers various skill development courses across different disciplines. The Institution committed/commits participants every year for any of the above listed services. The timing/duration of the activities shall be arrived on mutually agreed dates. The fee will be decided time to time based on the type of activity and the level of required input.

1.6 Any specific activity developed under this MOU shall be detailed in a subsequent agreement, signed by each institution's authorized signatory, which will describe the scope of the proposed activity, intended outcomes, budget, and responsible departments or individuals.

1.7 All activities shall be subject to the availability of funds and the approval of each institution's authorized representatives.

## 2: DURATION AND EVALUATION

2.1 This MOU shall be in effect for a period of Five years from the last date of signature. Either party may request termination of this agreement, in writing, ninety (90) days prior to the proposed termination date. Any activities in progress at the time of termination shall be permitted to conclude as planned unless otherwise agreed in writing.

2.2 If the MOU is not cancelled by any party, it will be automatically renewed for another Five Years. In case of any concerns or amendments, a joint evaluation of the MOU will be initiated by the designated representatives six (6) months prior to the expiration date. Following the evaluation, the MOU may be renewed and resigned for an additional five (5) year period (non-binding in nature).

2.3 Amendments to this MOU may be requested, in writing, by either party and approved by the authorized signatories.

## 3: EQUALITY, DIVERSITY & INCLUSION

The parties agree not to discriminate on the basis of religion, race, creed, national or ethnic origin, gender/sex, age, handicap, political affiliation, sexual orientation, disability or status as a veteran. We will support equality, diversity and inclusion.

## 4: COMPLIANCE WITH LAW

The parties specifically intend to comply with all applicable laws, rules and regulations as they may be amended from time to time. If any part of this Agreement is determined to violate federal, state, or local laws, rules, or regulations, the parties agree to negotiate in good faith revisions to any such provisions. If the parties fail to agree within a reasonable time to revisions required to bring the entire Agreement into compliance, either party may terminate this Agreement upon thirty (30) days prior written notice to the other party.

## 5: FORCE MAJEURE

In the event students are unable to complete the Program due to causes beyond the control of the institution, including, but not limited to: acts of God; war; acts of the government; fires; floods; epidemics; quarantine restrictions; strikes, labor disputes or work stoppages; transportation contingency; and freight embargoes; other catastrophes or any similar occurrences beyond institution's reasonable control, institution will assist the affected students in finding an alternate solution to complete the Program.

## 6: SERVICES

Iterative Services with the Clients, Suppliers and Collaborators/Funders referred to by the Company: In as much as both parties will acquire or have access to information, which is of a highly confidential and secret nature, it is expected that the Institution will not perform any services to the referred clients, supplier and/or collaborator/funder without mutual prior written approval and agreement.

## 7: USE OF NAME

None of the parties shall use the name, logo, likeness, trademarks, image or other intellectual property of either of the other parties for any advertising, marketing, endorsement or any other purposes without the specific prior written consent of an authorized representative of the other party as to each such use. From the date of signature, both the parties will co-brand for all the joint initiatives listed above.

## 8: CONFIDENTIAL INFORMATION AND INTELLECTUAL PROPERTY

Both parties agree that it will not assign, sell, transfer, delegate or otherwise dispose of, whether voluntarily or involuntarily, or by operation of law, any rights or obligations under this Agreement. Each party hereto ("Such Party") shall hold in trust for the other party hereto ("Such Other Party") and shall not disclose to any non-party to the Agreement, any confidential information of such Other Party. Confidential information is information which relates to Such Other Party's research, development, trade secrets or business affairs, but does not include information which is generally known or easily ascertainable by non-parties of ordinary skill in computer systems design and programming. Any Intellectual Property rights generated out of any projects will be discussed and mutually agreed upon with a specific MoU. Some of the models to kickstart maybe defined as

1. Direct Client Engagement – MIT Square may connect their clients/customers to the party directly and take the consultancy/referral fee.
2. Direct Investment – MIT Square may directly buy from the party and supply to their clients/customers/networks while keeping their margins.
3. Innovations in Product Designs and Features – Both parties may jointly work with mutual consent to create and develop innovative product. For this further agreement may be signed with detailed terms and other project-based detailing for each individual project.
4. Iterative Services with the Clients & Suppliers referred to by both the parties:

In as much as both parties will acquire or have access to information, which is of a highly confidential and secret nature, it is expected that each party will not perform any services to the referred clients and/or supplier by either party to the other without mutual prior written approval and agreement.

## 9: INDEPENDENT CONTRACTORS

Each party is separate and independent and this Agreement shall not be deemed to create a relationship of agency, employment, or partnership between or among them. Each party understands and agrees that this Agreement establishes an independent contractor relationship and that the agents or employees of each respective party are not employees or agents of any other party.

#### 10: SEVERABILITY

The provisions of this Agreement are severable, and if any provision of this Agreement is found to be invalid, void or unenforceable, the remaining provisions will remain in full force and effect.

#### 11: WAIVER

The waiver of any breach of any term of this Agreement does not waive any subsequent breach of that or another term of this Agreement.

#### 12: ASSIGNMENT

No party may assign this Agreement or any rights or obligations under this Agreement to any person or entity without the prior written consent of the other parties. Any assignment in violation of this provision is null and void.

#### 13: GOVERNING LAW

The parties shall comply with all applicable laws in performing Services. This Agreement shall be construed and enforced solely pursuant to the Indian laws, without giving effect to the principles of conflicts of laws thereof and the parties agree that this Agreement shall be subject to the jurisdiction of Bangalore.

#### 14: DISPUTE RESOLUTION

The Parties shall use their best endeavors to settle amicably any difference or dispute arising under or in connection with this MOU by consultation and negotiation. If a dispute cannot be settled through such consultation, upon the request of either Party with written notice to the other Party, any such dispute shall be resolved by arbitration in accordance with the Rules of Arbitration of the Indian Council of Arbitration and the award made in pursuance thereof shall be binding on the parties. The place of arbitration will be city of Bangalore

#### 15: ENTIRE MoU

This MoU constitutes the entire MoU and understanding between the parties as to the subject matter hereof and supersedes all prior discussions, agreements and undertakings of every kind and nature between them, whether written or oral, with respect to such subject matter. This MoU may subsequently be modified only by a written document executed by both parties.



#### 16: NOTICES

## **BACKGROUND**

## **2. IMPLEMENTING THE GOALS OF THE MoU**

- 2.1 The areas of cooperation between the Parties will be mutually agreed upon by the Parties.
- 2.2 Before engaging in any cooperation that involves an exchange of resources, funding, or the development or use of intellectual property, the Parties will enter into a separate written agreement covering the relevant aspects of funding and obligations pertaining to the specific project under consideration, which will be binding on each Party

## **3. COORDINATORS**

- 3.1 During the Term, each institution shall designate a coordinator for this Memorandum, who will serve to advise the partner on revisions, expirations, and any other matter concerning the language and spirit of this document.
- 3.2 The coordinators must consult with each other as reasonably required to review the operation of the MoU.
- 3.3 A Party may change its coordinator by providing written notice to the other Party

## **4. TERM, REVIEW, AND TERMINATION**

- 4.1 The implementation of this agreement will commence on the date of signing and remain in force for three years thereafter. It will automatically be renewed for an additional three years unless either party submits notice of termination within six months of the expiry date.
- 4.2 The Memorandum of Understanding may be amended or extended between two parties for specific activities agreed upon in writing as an addendum to this agreement.
- 4.3 Both institutions understand and concur that financial obligations associated with this agreement will be negotiated between parties and are dependent upon available resources.
- 4.4 This MoU may be unilaterally terminated by either Party by providing two (2) months' written notice to the other Party.

4.5 Any separate agreement entered into by the Parties (as set out in Clause 2) may survive termination or expiration of this MoU.

## **5. EFFECT OF MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding serves only as a record of the Parties' intentions and does not constitute or create, any legally binding or enforceable obligations, expressed or implied, under domestic or international law.

## **6. NO AGENCY**

Nothing contained herein is to be construed so as to constitute a joint venture partnership or formal business organization of any kind between the Parties or so to constitute either party as the agent of the other.

## **7. INDEMNITY**

Both the parties hereby agree to indemnify and hold harmless each other against any and all damages which directly arise out of, or result from, or may be payable by virtue of:

- falsity, incompleteness, default, breach, or inaccuracy of any of the claims, representations or obligations set under this MoU.

## **8. DISPUTE RESOLUTION**

Any dispute arising out of the interpretation or implementation of this MoU shall be settled amicably by consultation or negotiation among both parties.

## **9. CONFIDENTIALITY**

The Parties acknowledge that they shall, in the course of performing their responsibilities under this MoU, if or when exposed to or acquire confidential information concerning either Surana Educational Institutions or Navjyoti India Foundation, shall hold to this confidential information in strict confidence and not to copy, reproduce, sell, assign, license, market, transfer or otherwise dispose of, give or disclose such information to third parties, and not to use such information for any purposes whatsoever other than the performance of this MoU. This stands true for any and all of the Parties' affiliates or employees who have this information through the same.

## MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding ("MOU") is executed at Bangalore on 17<sup>th</sup> July 2022 ("Execution Date"), by and between:

Ltd**, a company incorporated under Companies Act, 2013, having its registered office at HV Cypress-II, No. 96, Kavi Lakshmisha Road, VV Puram, Bangalore, Karnataka- 560004 (hereinafter referred to as "**Dalham**" which expression shall, unless repugnant to the context or meaning thereof be deemed to mean and include its associate/group entities, successors-in-interest and permitted assigns) of the **FIRST PART**;

**AND**

**Surana College (Autonomous), Bangalore** incorporated under 16, S End Rd, Basavanagudi, Bengaluru, Karnataka 560004 (hereinafter referred to as "Partner Institute" which expression shall, unless repugnant to the context or meaning thereof be deemed to mean and include its successors-in-interest and permitted assigns) of the **OTHER PART**.

Dalham and Partner Institute shall individually be referred to as "**Party**" and collectively as "**Parties**".

### WHEREAS:

- A. Dalham is inter *alia* engaged in the business of providing online Liberal Education and has developed an online application which offers a unique and innovative online course in the area of liberal education under the brand name DALHAM Learning ("**Dalham Application**") for the youth of India as more particularly detailed in **Annexure A** of this MOU ("**Dalham Course**"). The Dalham Course helps the students in developing the learning outcomes that are essential for their personal and professional life. The Dalham Course apart from imparting the liberal education to the students also helps the institutes in assessing and rating the progress of each and every student through Dalham Application.

NOW THEREFORE IT IS HEREBY AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

## 1. PRINCIPLE UNDERSTANDING

Pursuant to mutual discussion and understanding:

- 1.1. Partner Institute is desirous of including the Dalham Course in their curriculum by availing the license to use the Dalham Application for the Term. In this regard, Dalham has agreed to grant the Partner Institute the license to use the Dalham Application to its students for accessing the Dalham Course for the Term, on the terms as detailed below.

Further it is agreed between the Parties that notwithstanding anything contained under this MoU, the Parties shall not be entitled to terminate this MoU during 3 (three) years from the commencement of the Dalham Course for Partner Institute's UG and PG Program. However, prior to expiry of the Term, the Parties may mutually agree to renew this MOU for such further period on terms as may be mutually agreed between them.

## 3. FINANCIAL UNDERSTANDING

### 4.1. Grant of rights:

**4.1.1.** Dalham hereby grants a limited, non-exclusive, conditional, non-transferable license to the Partner Institute to (i) access the Dalham Application and use the Dalham Course and content thereto during the Term solely for the purposes as defined herein under this MoU; (ii) use the brand, title, name, and logo of Dalham as per Dalham's brand guidelines on its official website and any other communication collaterals solely and exclusively for the purposes of promoting, marketing and advertising the association between the Parties as contemplated under this MOU.

**4.3.** Partner Institute hereby agree and acknowledges that the Dalham shall be the owner throughout the world in perpetuity of the Dalham Application, Dalham Course and the content provided therein and/or any other intellectual property right in relation thereto and further acknowledges and undertakes that it will not claim, during the Term and any time thereafter, any title in and any intellectual property rights by virtue of any rights granted hereunder.

## 5. REPRESENTATION AND WARRANTIES

Each Party to this MOU makes the following representation and warranties:

- (i) The person signing this MOU has the legal power and authority by virtue of statute/resolution, to sign this MOU for and on behalf of the Parties and to perform and comply with its duties and obligations hereunder.
- (ii) This MOU constitutes legal, valid and binding obligation enforceable against it in accordance with the terms hereof and represents that there is no contract, agreement or understanding with any person, partnership, or any other entity/authority restricting or preventing it from performing its obligations/deliverables under this MOU.

## 6. TERMINATION AND CONSEQUENCES OF THE EXPIRY AND TERMINATION

- 6.1. Subject to the Lock-in Period, either Party shall have the right to terminate the MOU by giving 60(Sixty) days prior written notice to the other party in the event either Party commits breach of any of their respective representation, warranties, deliverables under this MOU ("Defaulting Party"), and such breach is not remedied (if capable of remedy) within abovementioned notice period.
- 6.2. **Consequences of Termination or expiry:**
  - 6.2.1. The Parties shall refrain from showing any form of association with each other for the matter hereof;
  - 6.2.2. The Parties shall cease to use and return any/all information Dalham content, Lectures, data, Intellectual Property Rights, Confidential Information (if any) of each other;
  - 6.2.3. All of the licenses, rights and benefits assigned to Partner Institute in the Dalham Application and Dalham Course by Dalham pursuant to the MOU shall revert to Dalham and Partner Institute shall and shall ensure that the students should not use the content of Dalham Courses for any purposes whatsoever.
  - 6.2.4. The Partner Institute shall within 15 days from the termination, pay the amount due and payable to Dalham.

- 7.2. Notwithstanding anything contained in this MOU, the maximum aggregate liability of Dalham shall not exceed the Consideration received by Dalham in the last quarter from the date such liability has arisen.

## 8. CONFIDENTIALITY

8.1. The Parties acknowledge that any information, which is not publicly available and is provided by one Party including without limiting to the terms like Principal Understanding, Financial Understanding agreed between the Parties under this MoU (the “**Disclosing Party**”) to the other Party (the “**Receiving Party**”) for the purpose of implementing this MOU shall be confidential information and shall not be disclosed by the Receiving Party to any third party without the prior written consent of the Disclosing Party.

8.2. No public announcement/press releases/media releases shall be made by either Party of the contents of this MOU and any other terms agreed between the Parties qua this association, unless mutually agreed.

## 9. FORCE MAJEURE

Neither Party shall be liable for delay in performance of its responsibilities/obligations hereunder which may be caused by an act which is beyond the reasonable control of either party (“Force Majeure Event(s)”. Should the Force Majeure Event subsist for a duration longer than 60 (Sixty) days, the Parties shall mutually agree the way forward including the right to terminate this MOU by serving a 90 (Ninety) days’ prior written notice.

## 10. GOVERNING LAW

This MOU shall be governed by the applicable laws of India and the courts of Bengaluru, Karnataka shall have exclusive jurisdiction to adjudicate upon any dispute arising under this MOU.

## 11. NOTICES

All notices or other communication to be provided under this MOU shall be in writing, and may be communicated by the mode of communication which shall be sent by courier, registered post with acknowledgment due, followed by email or e-mail, to the contact details of the relevant Party as may be communicated in this regard.

## 12. ENTIRE AGREEMENT



## MEMORANDUM OF UNDERSTANDING (MOU)

Referred to as the Learning Provider / CFO NeXt

SURANA COLLEGE(AUTONOMOUS) represented by its Principal: Dr. M.R.Bhavani, having its premises at 16, south end road, Basavanagudi, Bangalore, Karnataka-560004.

Now this Memorandum of Understanding Witness as under: -

### 1) Purpose of MOU:

The purpose of the MOU is to have a common goal of carrying out ACCA — UK course at the esteemed institution. Such a course shall benefit the students in their career and provide an added advantage to the students of the University.

ACCA stands for Association of Chartered Certified Accountants and it provides a Chartered Accountancy degree from United Kingdom (U.K). ACCA was founded in 1904. ACCA has consistently held unique core values: opportunity, diversity, innovation, integrity and accountability. ACCA believes that accountants bring value to economies in all stages of development. ACCA aims to develop capacity in the profession and encourage the adoption of global standards. Our values are aligned to the needs of employers in all sectors and we ensure that, through our qualifications, we prepare accountants for business. We seek to open up the profession to people of all backgrounds and remove artificial barriers, innovating our qualifications and their delivery to meet the diverse needs of trainee professionals and their employers.

### 2) Roles and Responsibilities of CFO NeXt

CFO NeXt shall be entrusted with the following roles and responsibilities: -

- a) Branding and Marketing of ACCA at the college to motivate students to take admission.
- b) Support University to get the minimum batch size of students by promotions and Branding.
  - ) To carry out registration of the students / candidates under the registration policy guidelines of ACCA.
- d) To support the college in all the technical information required at their end about the details and conduct of the courses.
- e) Carry out all the required trainings and teachings of the courses at the premises of the college.

- i) Collect all fees from the students towards ACCA Fees, content fees for BPP and the tuition fees for CFO NeXt.
- j) Carry out Bridge course training of 30 hours towards the exempted papers to strengthen the basics of the students.
- k) Carry out complete exam oriented coaching towards the 3 skill level papers FR,AA,FM of 60hours or more per paper to ensure maximum progression.

### 3) Roles and Responsibilities of the college

The college shall be entrusted with the following roles and responsibilities: -

- a) Carry out seminars *and* introductory sessions on ACCA in the college premises along with the learning partner.
- b) Support CFO NeXt to Bring about awareness about the course to all the streams of commerce and business education in the college.
