MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) is entered on this 10th day (Thursday) of August of the year 2017.

BY AND BETWEEN

Entrepreneurship Development Institute of India, having their registered office at Ahmedabad (Near Village Bhat) P.O. Bhat 382428 Dist. Gandhinagar Gujarat, represented by Mr. Raman Gujral Head & Faculty, EDII South India hereinafter referred as EDII or the party of the first part and shall include all their representatives,

AND

Surana College, Centre for Post Graduate Studies, Bangalore, Karnataka, India having their campus at # CA-17, Mysore-Tumkur Ring Road, Kengeri Satellite Town, Bangalore, Karnataka India, represented by its Associate Dean (Academic & Administration) and hereinafter referred to as Surana College or the party of the Second Part and shall include all their representatives.

WHEREAS Entrepreneurship Development Institute of India (EDII), an autonomous body and not-for-profit institution, set up in 1983, is sponsored by apex financial institutions, namely the Industrial Development Bank of India (IDBI), the Industrial Finance Corporation of India (IFCI), the Industrial Credit and Investment Corporation of India (ICICI) and State Bank of India (SBI). The Institute is registered under the Societies Registration Act 1860 and the Public Trust Act 1950. The Government of Gujarat pledged twenty-three acres of land on which stands the majestic and sprawling EDII campus, hereinafter referred as EDII, having expressed interest as knowledge partner in associating with Surana College to offer two programs related to Entrepreneurship and Business Management, PG/UG students of Surana College.



- i. 6 Months Certification in Entrepreneurship and Management (CEM), on exclusive basis at Post Graduate level details provided as per Annexure 1
- ii. 3 Days' Entrepreneurship Awareness Camps (EAC) with details provided in Annexure 2

And whereas both the parties agree upon the terms and conditions of their association are desirous to conduct the program as hereunder.

- EDII agrees to offer the above mentioned two programs as a knowledge partner at the
 post graduate level students of Surana College, to start with and later on to other
 students of the associated institutions. However, EDII reserves the right to offer similar
 programs to other institutions in the country in future.
- Surana College will promote the program on its own using print and electronic aids and will acknowledge the name of EDII prominently in all the promotional literature and material.
- Surana College will provide the classrooms and other infrastructure for conducting the program, but will not reimburse any other cost since it is the part of the fees.
- Surana College agrees to review the facilities provided to EDII on a regular basis to
 ensure smooth implementation of all the above mentioned three programs.
- Surana College agrees to offer 6 Months Certification in Entrepreneurship and Management (CEM) and 3 Days' Entrepreneurship Awareness Camps (EAC) to its students of MBA to start with and later on to other students of associated institutions in consent with EDII.
- 6. EDII as a knowledge partner agrees to conduct 6 Months Certification in Entrepreneurship and Management (CEM) and 3 Days' Entrepreneurship Awareness Camps (EAC) as per the allotted and agreed time table/schedule.



- 7. Surana College agrees to pay to EDII the mutually agreed fees for 6 Months Certification in Entrepreneurship and Management (CEM) and 3 Days' Entrepreneurship Awareness Camps (EAC). In addition, a prescribed application form fee will be paid by Surana College for registered students. The fees are subject to revision on mutually agreeable terms.
- 8. EDII will upgrade the curriculum from time to time, to meet the business / corporate/ industry needs, if required
- 9. The duration of the MOU is for a period of 2 years effective from the date of signing the MOU and revisable on a mutually agreeable basis. Surana College will deposit a non interest bearing, refundable deposit of Rs. 25,000/- with EDII. EDII will refund the caution deposit of `.25,000/- after the minimum enrolment of 40 students during one year period from the date of signing this MOU by the Surana College, is achieved. However, if the above mentioned conditions are not complied with, the caution deposit of `.25,000/- will be forfeited by EDII
- 10. EDII reserves the copy right for content/other relevant aspects of all the aforesaid mentioned programs.
- 11. Surana College agrees to keep the content/other relevant aspects of all the aforesaid mentioned programs confidential.
- 12. EDII & Surana College jointly agree to review the feedback of all the aforesaid mentioned programs and make suitable revisions, if necessary, on mutually agreeable terms.
- 13. EDII agrees to provide own/guest faculty for all the aforesaid mentioned programs.
- 14. Surana College agrees to provide own faculty for guiding and monitoring students for project works (separate projects each year as mentioned in Annexures). Surana College also agrees to pay to EDII faculty additional honorarium for guiding students for project works, in those cases where internal faculty is not available, on mutually agreeable honorarium basis.



- Summa College agrees to pay to EDH separately for the students of all the aforesaid mentioned programs visiting EDH Ahmedabad Campus if any, for short duration teaching/training during the course. This payment will be as per EDH norms. EDH reserves the right to review and increase such expenses in future.
- 16. EDMI agrees to send its faculty from Ahmedabad to program location if required for some critical course(s) on actual cost basis.
- EDMI will support Surana College for conducting different training programmes, workshops, camps, seminars and conferences supported by different governmental and other agencies.
- 18. EDMI will support Surama College by highlighting about the Course offered in their website to enable the aspiring students and their parents about the association and giving mileage to the above program. Surama College will provide draft content to EDII for the same.
- 19. EDII will jointly with Surana College provide the final Certificate for the programmes.
- 201. EDII will not be liable to make any payment/ financial incentive/ reimbursement of expenditure to Surana College or will not be responsible for any legal/ statutory/ tax related obligations.
- 21. Neither party shall be held responsible for non-fulfilment of their respective obligations under this agreement due to exigency of one or more of the force majeure events such as but not limited to acts like floods, earthquake, strike, lockouts, epidemics, riots, wars and commotions etc., provided on the occurrence and cessation or cessation of such events, the party within one month of such occurrence or cessation. If the force majeure conditions continue beyond six months, the parties shall then mutually decide about the future course of action.



This Agreement shall be governed by and construed in accordance with the laws of the State of Gujanat. Any dispute arising out of, or in connection with this agreement shall be subject to the exclusive jurisdiction of the courts of Gujanat.



- College shall admit the candidates for the NCFM certifications and collect the certification
 fees and remit the entire amount collected towards the course to NAL either through DD
 or online mode before the examination.
- NAL shall create a corporate login in NCFM online portal for the College to enroll
 candidates for examination, check account balance and examination results of the
 candidate.
- 6. NAL shall provide its online testing platform for conducting the certification examinations.
- 7. College will be responsible for the registration and enrollment of the candidates for the test through the online portal provided by NAL.
- College should finalize the date, time and venue of the end term examinations and inform NAL at least before 7 working days.
- NAL shall do sanity checks of the testing infrastructure 2 working days prior the date of
 examination. The College shall provide its co-operation for the same.
- 10. College shall co-ordinate with the candidates and provide necessary assistance and guidance to solve the candidate's queries before and after the examination.
- 11. College will be solely responsible of the test invigilation and supervision.
- 12. The batch size to conduct examination for a single day should be minimum of 20 students.
