4.1. Dr. Veena. KN Member Secretary on checking & confirming the quorum for the meeting, requested Dr. Dilip Surana, The Chairman of Governing body to initiate the Meeting.

After obtaining formal permission by the Chairman, Dr. Dilip Surana, Dr. Punith Cariappa, Group director of SEI & Member of the Governing Body welcomed all the participating members of the Governing Body for the 4th meeting. Also introduced the new principal Dr. Veena. KN & newly appointed Bangalore University Nominee BUB. Dr. V Sudhesh to the Governing Council.

Later Dr. Punith Cariappa requested Dr. Veena KN, Member Secretary to takeover the rest of the proceedings.

4.2. Review and Conformation of the 3rd Governing Council Meeting held on 31st October 2023.

Member Secretary discussed the minutes of the 3rd Governing body Meeting held on 31st October 2023.

Resolution:

All the members present online & offline consented to the presentation and the minutes of the 3rd Governing Body meeting were confirmed.

4.3 Review and Approval of 5th Academic Council Minutes - Meeting held on March 27, 2024 (including its Addendum)

Member Secretary highlighted the functioning & key points discussed in the 5^{th} Academic Council Meeting held on 27^{th} March 2024. This review specially highlights all the key decisions from the Academic Council meetings, particularly Focus on Launch of New Program from the upcoming academic year 2024-25

- a. **Master of Arts (M.A.) in Media Studies (Intake: 40):** This program equips graduates with critical thinking, research, and communication skills in the dynamic field of media studies.
- b. **Master of Science (M.Sc.) in Psychological Counselling (Intake: 40):** This program provides advanced training in psychological assessment, intervention techniques, and ethical considerations in counselling.





- c. Master of Business Administration (M.B.A.) for Working Professionals (Under Supernumerary Quota) (With AICTE Approval) (Intake: 60): Subject to AICTE approval, this program caters to working professionals seeking an MBA while managing their careers.
- d. Fellow Program in Management (F.P.M.) (With AICTE Approval) (Intake: 10): Subject to AICTE approval, this doctoral-level program focuses on advanced management research.
- e. **Master of Science (M.Sc.) in Analytical Chemistry (Intake: 30):** This program provides in-depth knowledge and practical skills in analytical chemistry techniques and applications.

Suggestions:

Prof. Rajiv Chopra Suggested these new programs undergo a formal approval process by the designated authorities to ensure compliance with existing regulations.

Dr. Archana Surana elaborated that the team will be actively working to secure all necessary approvals from the relevant authorities. She also acknowledged the need for approvals and clarified that her team will navigate the process to obtain them from the appropriate authorities.

Deliberations:

Admissions Timeline:

- Prof. Rajiv Chopra (UGC Nominee) enquired about the current year's admissions timeline.
- Mr. Naveen Jaiswal (Admissions Head) presented the admission statistics as on 4th June and addressed the eligibility criteria for M.Sc-Psychology as a challenge in attracting interested students.

Low Enrolment in Specific Programs:

 Prof. Gururaja Karajagi (Veteran Academician) expressed concern about declining enrolment in BA, B.Sc., and M.Sc. Psychology programs and suggested to add Value Addition Courses to attract students.

M.Sc. Psychology Admissions:

• Mr. Naveen Jaiswal explained that stricter eligibility criteria set by the affiliating university for M.Sc. Psychology pose a significant hurdle.

Challenges in B.Sc. & M.Sc. Psychology:

- Dr. Archana Surana highlighted additional challenges in B.Sc admissions due to competition from engineering colleges.
- She further elaborated on the nomenclature difference between BA and B.Sc. Psychology, creating confusion among students and parents who perceive B.Sc. as the superior option.

Comparative Eligibility Criteria:

• Prof. Jayappa (Government Nominee) proposed gathering eligibility criteria from other universities to present to Bangalore University as a precedent for potential liberalization of our own criteria.

Enhancing Program Attractiveness:

 Prof. Gururaja Karajagi suggested incorporating unique and engaging content into the curriculum to attract students. Appreciated addition of proposed new programs while checking on the approval requirements from BU & AICTE.

That the Member Secretary presented a request for approval of student admissions made during the academic years 2023-2024 and 2024-2025 (ongoing admissions).





Resolution: -

Resolved That the Governing Council hereby approves the aforementioned student admissions for the academic years 2023-2024 and 2024-2025.

e. Curriculum development and innovation.

- c. Adopting innovative teaching methodologies and assessment strategies.
- d. Promoting interdisciplinary and collaborative learning.
- e. Enhanced Student Learning through Emphasizing the improved student learning outcomes achieved through a dynamic and relevant curriculum, preparing them for future success.
- f. Faculty Development: Opportunities for faculty to actively participate in curriculum development and stay updated in their fields.
- g. Reputation: Positioning the college as a leader in educational innovation, attracting talented students and faculty.

Deliberations: -

- Dr. Meena Kumari presented the aforesaid & current practices in curriculum development and innovation.
- Prof. Gururaja Karajagi enquired about:
 - o Frequency of FDPs.
 - Need for specialized training for new faculty members on induction, teaching methods, and research methodology.
 - Suggested conducting orientation for new faculty.
- Dr.Vanishree.M.R clarified the existing practices and plans for faculty development in the upcoming semesters.
- Dr. Anil Rao Paila enquired about the existing mentorship program and emphasise on the importance of mentoring.
- Dr. Meena Kumari explained the current practices.
- Dr. Rajiv Chopra suggested implementing a formal mentor-mentee system.
- The Principal confirmed the existing system with psychology department acting as a mentor.
- Prof. Gururaja Karajagi proposed:
 - A mentor-mentee ratio system.
 - o Clear guidelines on the mentor's role.
 - Establishing a helpline for mentees.
 - Conducting orientation on Mentoring for faculty
- Dr. Anil Rao Paila enquired about options for fast learners to pursue additional value-added courses.
- The Principal provided details on the existing value-added programs offered.
- Dr. Anil Rao Paila enquired about facilities for interdisciplinary learning.
- The Principal acknowledged the aspirations of the institution on interdisciplinary learning, and explained the challenges due to the implementation of the State Education Policy in Karnataka.





Approval Request:

 Following the deliberations, the Member Secretary requested the Governing Council's approval for the presented curriculum development and faculty development initiatives.

Resolution: -

The Governing Council extends its appreciation to the institution for its commendable efforts on **Curriculum development and innovation**. Following a thorough review, the Council has granted its approval."

f. Implementation of New SEP from 2024-25

- a. Karnataka government scrapped the NEP (National Education Policy) 2020 with four-year degree programme in public universities and affiliated colleges, and has reintroduced the three-year degree programme under State Education Policy 2024 (SEP with no option of a fourth year) for the academic year 2024-25.
- b. Surana College, as an autonomous institution, recognizes the importance of aligning its curriculum with the guidelines outlined in the Karnataka State SEP 2024.

The Member Secretary briefed to The Governing Council on the Karnataka State Education Policy (SEP) 2024. The SEP is slated for implementation by the State Government from the academic year 2024-25. The Member Secretary formally sought the Council's guidance and support in adopting and implementing the regulations outlined in the SEP.

Resolution:

Following the presentation on the Karnataka State Education Policy 2024, the Governing Council unanimously approved its implementation as per the State Government's guidelines.

g. Teaching-learning methodologies and student performance.

The Principal and Member Secretary presented on the institution's teaching-learning methodologies and their impact on student performance, as detailed below.

Surana College utilizes a diverse range of teaching-learning methodologies to enhance student performance, progression, and achieve optimal results.

• **Interactive Learning:** Lectures are complemented by collaborative activities like group discussions, case studies, and problem-solving exercises. This fosters active participation, critical thinking, and deeper understanding.

 Technology Integration: The college leverages technology effectively through virtual learning platforms, digital resources, and multimedia tools. This enriches the learning experience, promotes accessibility, and allows for personalized learning.



• **Student-Centric Approach:** The focus is on student engagement and active learning. Instructors use various methods like flipped classrooms, where students prepare beforehand and class time is used for discussion and application.

Assessment and Feedback: Regular assessments and timely feedback are provided to students. This allows them to identify areas of strength and weakness, track progress, and make informed adjustments to their learning

strategies.

• **Mentorship and Support:** The college offers dedicated mentorship programs and academic support services. This provides students with guidance, personalized assistance, and resources to overcome challenges and excel in their studies.

By implementing these diverse methodologies, Suran College fosters a dynamic learning environment that caters to individual needs and empowers students to achieve their full potential & resulting best outcome.

The Member Secretary formally sought the Council's suggestions & approval on this.

Resolution: -

The Governing Council commended the College's ongoing efforts in developing effective teaching-learning methodologies, resulting in demonstrably improved student performance. The Council formally approved the continuation of these practices.

h. Research activities and publications.

Dr. Vanishree MR, Dean of Research & Consultancy, presented an update on research activities and publications undertaken during the year 2023-24. She also provided the Governing Council members with relevant statistics on publications, book and grants.

- Registration for Ph.D by Surana faculty members has increased. Around 24 faculty members have registered for Ph. D and 28 faculty members have completed their doctoral degrees from various premier universities. Constant support and guidance for Ph.D registration is provided by R&C Cell.
- 2. Under Research Publications and IPR:
 - a. Totally 32 Scopus Indexed/WOS/ABDC published with highest impact factor of 9.4. Publications towards Scopus Indexed Journal were contributed from different disciplines including management, library sciences and humanities.
 - b. 20 UGC Care listed research publications, 3 books (reference books), 13 book chapters, 29 textbooks (Bangalore University) and 33 research papers were presented in International and National conferences by faculty members.
 - c. Received 4 patent approvals from Indian patent office. Contributors Dr. B G Lakshmi, Mrs. Prakruthi N Udupa, Mr. Gururaj F Duragannavar and Dr. Farzana Tasneem MI. Dr. B G Lakshmi & team got approved a copyright titled "Employment Benefits in Foreign Education Vs. Indian Education: A Comparative Study" Copyright Office, Government of India.





- d. Our faculty members are actively contributing as Editorial members (15 Journals) International and National; external Ph. D examiners and expert session resource persons at various forums.
- e. R&C Cell is providing requisite information and support for faculty members to take up Post Doctoral Fellowship / International Fellowship opportunities.
- 3. Under External Research Funded Projects/ Grants following progress were done:
 - a. Completed: ICSSR, New Delhi Sponsored National Seminar "Rebuilding Bharat Through Indigenous and Innovative Practices: A Way Forward to Vishwa Guru" and published 38 research papers in edited book with ISBN number. Grant Amount Rs. 3,50,000/-.
 - b. Completed: Collaborative Grant to host a Lecture Series on title "National Reconstruction on the light of Swami Vivekananda's Cultural and Philosophical Thoughts: Present and Futuristic Perspectives" was hosted by Department of Hindi, Sanskrit and Research & Consultancy Cell. Grant Amount Rs. 40,000/-.
 - c. In Progress: Dr. Sudharshan H L have received research project grant (2-years) on Compiling Indian Concepts on Mental Wellbeing from NIVS, New Delhi. Grant Amount Rs. 2,10,000/-.
 - d. Faculty members upskilled with relevant training and support to apply for external research proposals such ICSSR Collaborative Proposal Viksit Bharat@2047, VGST and other private funding agencies based on their interest and expertise.
- 4. Under Capacity Building Training/ Conference:
 - a. Completed 8 FDP/Workshop (Offline & Online). FDP on "Teaching, Learning and Research Excellence" received a lot of appreciation from the participants. Amount Generated: Rs. 29,400/- through registration fee.
 - b. Completed Student Research Conference on "Gig Economy and India: Prospectus, Challenges and Way Forward Strategies". 62 research papers from students and scholars across India and received tremendous appreciations from all the participants. Amount Generated: Rs. 1,89,800/- through sponsorship and registration fee.
 - c. To nurture and strengthen research ecosystem among faculty members and students, R&C Cell initiated Seed Grant Scheme and Student Research Fellowship. Dr. Pooja R received Seed Grant scheme. 4 UG Students and 8 PG Students have awarded with Student Research Fellowship for year 2023-24.
 - d. All requisite monitoring and evaluation framework are in place to ensure research quality deliverables by the SEI.
- Surana Well Being Center (Consultancy Servies) Head by Dr. Sudharshan and Team successfully completed various assignment- training on Counselling Skills for Yoga Teachers, Research Consultation at St. John's Research Institute (funded by Gates Foundation) and Academic Consultation on IKS at M S Ramaiah University. Clinical





Consultation for General Public and In-house is regularly done. Surana Well Being Centre has generated revenue worth of Rs. 2,84,000/-.

6. Corporate Consultancy on Data Visualization for Executives and Mid-level Manager for L& T Technologies Pvt. Ltd (Mysore & Bangalore) generated revenue of Rs. 70,000/-.

7. Consultancy Service and Training Policy amended with revenue sharing proportion and approved by the concerned officials.

8. R& C Cell is looking forward for more of International and Industry Collaborations to enhance its research deliverables both for academic and industry stakeholders.

Following Dr. Vanishree's comprehensive presentation on research activities and publications, the Governing Council appreciated Research & Consultancy Cell efforts and considerable progress.

Suggestions:

- Dr. Chopra suggested that we have our own institutional journal and the same was agreed, Dr. Vanishree briefed on work in-progress towards the institutional journal.
- Dr. Karajagi emphasized the importance of research publications by Ph.D. holders. He commended the publication of 28 textbooks but recommended authorising reference books. Additionally, he suggested collaborations with "NIMHANS" to leverage expertise for both Well-being Center and its students.
- Dr. Karajagi suggested for creating help line number for emergency counselling for students and public, which will be taken by trained counsellors.
- Dr. Anil Rao Paila inquired about the ABDC rating, which Dr. Vanishree reported as "C." Dr. Paila expressed his appreciation and suggested implementing student research evaluations. He also enquired about case studies, to which Dr. Meena Kumari (Dean of Academics) clarified that they are in the development stage.

Resolution: -

The Governing Council reviewed the activities and publications undertaken by the Research & Consultancy Cell during its recent meeting. The Council expressed its great appreciation for the R&C Cell efforts. They acknowledged the R&C Cell achievements and offered valuable suggestions for further strengthening its research endeavours. Specifically, the Council members recommended strategies to enhance the department's robustness. Following a productive discussion, the Governing Council unanimously approved the continuation of the Research & Consultancy Cell current initiatives, along with the implementation of the new proposals.





Infrastructure development and resource management.

The Governing Council reviewed the significant infrastructure enhancements undertaken during the session, as presented by the Member Secretary. These improvements, including additional classrooms, laboratories, research facilities, expanded learning resources, digital displays, a canteen, a dedicated examination unit, and an admissions office, were acknowledged as greatly improving the learning environment for Surana College students.

Resolution:

The Council expressed its appreciation for these advancements in infrastructure and resource management, recognizing their positive impact on the student community. Following the review, the Council formally ratified and approved the budget allocated for these essential requirements.

j. Student Placement statistics.

a. No of Placement activities conducted : 51b. No of students called & appeared for interview : 310

c. No of students placed. : 123 Students

d. Highest package in PG : 8 LPA
e. Highest package in UG : 6.1 LPA

Discussion: -

During the Governing Council meeting, Mr. Kiran, the Placement Officer, presented a report on placement activities for the session. Dr. Jayappa suggested that the placement section prioritize programs like B.Com, B.Sc., and BA, given the abundance of opportunities in BBA and BCA programs. Dr. Gururaja Karajagi inquired about the placement percentage, which Mr. Kiran reported as 40%. Dr. Anil Rao Paila offered several recommendations for improvement:

- Establish Memoranda of Understanding (MoUs) with corporations to create stronger industry connections.
- Segregate placement data for undergraduate and postgraduate programs for better analysis of trends.
- Collect student feedback on salary and company satisfaction to identify areas for improvement in future placements.
- Form an alumni team to leverage their experience and networks in strengthening the placement process.

The Governing Council's discussion aimed to find ways to enhance the placement opportunities for all students.



k. Student Support

The Principal informed the Governing Council about the various government and management scholarships available to students during the current academic year. These scholarships are facilitated through both the State Scholarship Portal (SSP) and the National Scholarship Portal (NSP). The application process for these scholarships is still ongoing. It is important to note that the information displayed on both portals may not yet reflect the complete list of available scholarships, as the approval process is still underway.

a. Government Scholarships

SSP Scholarship: During 2023-2024, out of 338 students applied, 124 students have received scholarship.

During 2022-23, out of 500 students applied, 366 students have received scholarship.

b. <u>Institutional Scholarship:</u> Financial assistance provided to 357 Degree and 107 PG Students during 2023-24.

Resolution: -

Th Governing Council members appreciated the institution for helping a good proportion of students with scholarship and efforts in helping students get Government scholarship.

"Dr. Gururaja Karajagi emphasized the importance of recognizing the management's generous scholarship program, providing significant financial support to students. They recommended documenting this appreciation in the meeting minutes."

The Governing Council commended the College's efforts in facilitating student access to scholarships. They appreciated the management for establishing diverse scholarship programs, thereby providing crucial financial support that empowers students in their academic pursuits.

1. Alumni engagement activities.

Alumni Engagement Activities:

Mr. Muralidhar, HoD of Management, presented a report on the department's successful alumni engagement initiatives. The highlights included:

- Collaboration with alumni on approximately 14 activities throughout the year.
- Establishment of a Rs. 1,50,000 endowment fund in memory of BBA alumnus Sandesh (2009-2012 batch) to recognize and reward academic excellence among current BBA students.
- Upcoming Alumni Meet during August, 2024.





Discussion:

 Dr. Karajagi enquired about the number of alumni on record, to which Mr. Muralidhar responded that there are approximately 6,500.

 Dr. Anil enquired about the registration status of the alumni association and strategies for fostering continuous student-alumni connections. Mr. Muralidhar confirmed that the Surana College Alumni Association is registered as per regulations and assured the Council of ongoing efforts to further strengthen alumni engagement activities.

Resolution:

The Governing Council commended the department's achievements in alumni engagement and expressed its approval for the continuation of these valuable initiatives.

4.6. Review of Autonomous Functioning

"The Member Secretary led a discussion on the potential advantages and challenges associated with achieving autonomous status, along with considerations for implementing an effective curriculum design and delivery model. Details are provided below."

Advantages:

• **Increased Academic Freedom:** Surana College has gained greater autonomy in designing its curriculum, allowing for a more tailored and relevant educational experience for its students.

• **Enhanced Specialization:** The college can now focus on specific areas of expertise and offer unique programs that cater to niche interests and industry demands.

 Improved Infrastructure and Resources: With greater control over its budget, Surana College can invest in improving infrastructure, acquiring new equipment, and expanding its library resources.

• **Faculty Development:** The college can prioritize faculty development programs and attract highly qualified professors by offering competitive salaries and benefits.

• **Direct Interaction with Industry:** Surana College can forge closer ties with industry partners, leading to internship opportunities, guest lectures, and collaborative research projects.

Challenges:

- **Industry Alignment:** Ensuring that the curriculum remains aligned with the latest industry trends and employer expectations.
- Faculty Training: Providing training for faculty on new teaching methodologies and curriculum enhancement.
- Student Feedback: Regularly collecting and analyzing student feedback to identify areas for improvement in the curriculum and delivery.





- Assessment and Evaluation: Implementing effective assessment methods to measure student learning outcomes and program effectiveness.
- Resource Allocation: Ensuring that adequate resources are allocated to support the implementation of the curriculum, including technology, facilities, and learning materials.
- Outcomes Based Education: Implementing appropriate methods to evaluate Learning Outcomes.

Overall, Surana College's transition to autonomy presents both opportunities and challenges. By focusing on its strengths and addressing the challenges effectively, the college will continue to improve its curriculum design and delivery, providing students with a high-quality market relevant education.

Discussion:

- Dr. Gururaja Karajagi raised concerns about the limitations of Surana College's current autonomous status. He highlighted the lack of full autonomy, requiring constant university approval. Additionally, he pointed out the absence of autonomous colleges' student performance data in university rankings, leading to reduced visibility.
- Dr. Karajagi emphasized the importance of faculty commitment and a growth mindset. He recommended implementing weekly academic meetings and evaluation systems focused on quality education improvement, distinct from the university system. He also stressed the need for robust department-level activities.
- Dr. Archana Surana responded by mentioning her efforts to bridge the gap between junior and senior faculty through student feedback analysis. She assured the council of continued progress in this area.

Resolution:

While acknowledging the limitations of the current autonomous structure, the Governing Council expressed its overall satisfaction with the functioning of autonomous procedures at Surana College.

Success of examination and evaluation processes.

"Dr. Harish Ugraiah, in his role as Controller of Examinations (CoE), delivered presentation on Surana College's examination results. His presentation included a detailed analysis of student performance metrics, likely incorporating factors such as pass rates, grade distributions, and comparisons to historical data or industry benchmarks. This analysis would provide valuable insights for the Governing Council to assess the college's academic effectiveness and identify areas for potential improvement."

4.11. IQAC Highlights: 2023-2024

"To facilitate a productive discussion, the Principal and Member Secretary presented an analysis of the following key IQAC points for the Governing Council's consideration. Their goal was to leverage the Council's expertise in formulating effective strategies to address the following identified areas."

Academic Quality Assurance

- The Annual Quality Assurance Report (AQAR) for 2022-2023 was submitted and approved by the National Assessment and Accreditation Council (NAAC). The process for the 2023-2024 AQAR is underway.
- The annual report for 2022-2023 is ready for submission to the University Grants Commission (UGC).

Enhancing Student Skills

- Add-On & Value-Added Courses: A total of 42 courses were offered, ranging from theatre workshops to business analytics and machine learning. Collaborations with organizations like Nataka Bengaluru and Talent Avenues provided industryrelevant training.
- Field Visits and Internships: Students participated in 37 field visits and 523 internships. These included industry visits, research center tours, and workshops at prestigious institutions like IISc and IISC. Examples include a visit to the Press Club of Bangalore and 11 journalism internships.





Engaging Learning Environment

• **Student-Centric Approach:** A total of 111 activities fostered experiential learning. These included model making, group discussions, gamified learning, guest lectures, workshops, and demonstrations at Indian Institute of Science. Initiatives like "World Mental Health Day" celebrations promoted positive well-being.

Faculty Development

• Faculty Development Programs (FDPs) and Quality Improvement Programs (QIPs): Eighteen programs were conducted, covering diverse areas like subaltern literature, advanced functional materials, and outcome-based education.

Building Collaborations

 MoUs, Collaborations, and Linkages: Thirty-three collaborations were established, including partnerships with hospitals, colleges, government bodies like YuvaTourism Club, and industry partners like LULU Group India for internships and training.

Professional Growth for Faculty

 Professional Development Programs: Forty-four programs supported faculty development. These included PhD pursuits, research methodology workshops, and professional certifications in fields like ACCA (Association of Chartered Certified Accountants). Notably, five research papers were published by the HOD of the PG Chemistry department.

Community Outreach

• **Extension Activities:** Twenty-eight activities fostered social responsibility and awareness. These included guest lectures on mental health, e-waste awareness drives, and student involvement in NGO micro projects.
